2.1. Purpose of the processing: We process your personal data for the following purposes:

- To manage your payments.
- To call you or send you emails to inform you about our services should it be necessary.
- To answer your requests for information, suggestions and complaints.
- To meet your requests (including employment applications through CVs).
- To deliver goods and services.
- W.E.C. Lines España, S.L.U. also processes personal data when legally obligated to do so, such as the data we require for our tax returns.

2.2. Lawful basis: We process your personal data on the basis of your consent, a contract and/or a legal obligation.

2.3. Storage period: W.E.C. Lines Spain, S.L.U. will store any personal data that you provide for as long as the relationship between both parties exists and no longer than the amount of time strictly necessary to achieve the purpose for which it was collected and in no case exceeding the applicable legal limitation periods.

2.4. Recipients of data-sharing: Personal data will not be transferred or disclosed to third parties except when required to execute a contract signed with you or to comply with a legal obligation. We have data processing agreements with the companies to which we transfer your personal data to ensure the same level of security and confidentiality. W.E.C. Lines España, S.L.U. will remain responsible to you for such data processing operations. With the exception of these cases, your express consent will be required for the transfer of personal data.

2.5. User rights

Access: You have the right to consult your personal data in the W.E.C. Lines España, S.L.U. database.

Rectification: You have the right to request the rectification of your personal data in the case of inaccuracies.

Erasure: You have the right to request the erasure of your personal data.

Objection: You have the right to request that your personal data not be processed.

Restriction of processing: You have the right to request the restriction of processing of your personal data.

Data portability: You have the right to request the portability of your personal data and the transfer thereof to other entities.

Likewise, you have the right to **withdraw your consent** at any time without this affecting the lawfulness of the processing. To exercise the aforementioned rights, you must include a copy of your national ID card or equivalent identification document with your request, which may be sent by post or email to the addresses found in the heading of this document. Likewise, in the event that you consider that your rights have been violated, **you may file a claim** with the Spanish Data Protection Agency (www.agpd.es) or any other official supervisory authority that you deem appropriate.
